They skillfully elucidate how Taha's use of description not only reconstructs space and time but also vividly captures the profound psychological experiences of the author and his fellow detainees. Through a descriptive analytical approach, the study reveals Taha's portrayal of the contradictions between the occupier and the occupied, and the intense struggles faced by prisoners in their efforts to humanize the enforced space. This work highlights the unique psychological dimensions stemming from the harsh reality of desert detention, presenting an authentic model of literary resistance that delves into the depths of descriptive language to craft a complex understanding of identity and place. This study opens new vistas for reevaluating literature as an effective tool for resistance, underscoring the critical importance of writing techniques in interpreting and shaping the experiences of confinement and dominance.

Following is a study by Mohammad Jamal Khalaf Albarakat, offering an in-depth analysis of Mahmoud Abdel-Moneim's "Lexicon of JurisprudentialTerms and Expressions," highlighting how the dictionary deals with sales terms in light of modern terminology. The research emphasizes the importance of terminological definitions in shaping jurisprudential concepts and provides a critical analysis of the definitional techniques used, reflecting the linguistic and methodological developments in lexicographical studies that draw from jurisprudential and prophetic texts.

In the third study, Ahmad Fahid Shahin, which delves into the stylistic features of extremist discourse in cyberspace, taking ISIS's rhetoric as a model for analysis. This research uncovers the linguistic and stylistic strategies used by the organization to spread its ideology, offering a deep understanding of how language serves extremist ideologies.

In the fourth study, Mohammad Basel Qadri and Abd Alkhaliq Esapresent a critical reading of the systemic political awareness in the hanging poems of Zuhair bin Abi Salma and Tarafa bin Al-Abd. The research explores how pre-Islamic poetic discourse reflects the political and social system of its era, indicating the role societal acceptance plays in shaping the fate and message of the poet.

The fifth study, by Dr. Zahir Al-Dawoodi, examines the image of the other in the customs and traditions of the people of Oman through tourist discourse, based on William Heid's journey. The research sheds light on how the image of the other is formed and its impact on tourism attraction, providing a critical view of cultural and historical representations.

The sixth study by Waleed Khalid Alhazmi explores Mohammed Abdelbari's poetry collection "A Song for Crossing the River Twice" through a semiotic study that investigates the signs and significations. The analysis covers the semiotics of the title, quotations, and visual composition of the text.

Finally, in the seventh study of this issue, researchers Zahir Al-Ghusaini and Idris Al-Hadrami conclude this edition's research with

a unique exploratory journey into the world of colors and their profound impact on human consciousness and in crafting poetic experience. They presented an approach that attempts to reshape our understanding of poetry and color perception, considering color as a bridge between reality and human emotions. This is from the perspective of two different poetic experiences in time and place (Ibn Khafaja of Al-Andalus and Suleiman Al-Nabhani of Oman), where the colors white and black played a fundamental role in expressing emotions and complex psychological states.
