Finally, the seventh research paper (by Chaker Mzoughi), in French, discusses 'Controlling Financial Markets in Qatari Law.'

This issue also contains a book review, titled: Islamic Law and International Law: Peaceful Resolution of Disputes, authored by Emilia Justyna Powell and published by Oxford University Press in 2020. Reviewed by Dr. Ioannis Konstantinidis.
