The ninth research paper (Al-Masry and Zahari) deals with the "Contractual Risk Allocation in Petroleum Industry - "Knock-for-Knock" as a Model." The tenth research paper (Abdallah), available in English, is concerned with the Islamic Sharia and Arbitration in GCC States: The Way Ahead. The last one (Al-Maadeed) sheds light upon "Nuclear Civil Liability Regimes and the Path Forward for the State of Qatar"
